"Menace XXIV" Scoring Sheet (Owner Dennis Conner)
Recommended rating from Chief Handicapper Dave Cattle is 12/12/12, an adjustment of -3/-3/-3.

"French Bred" Scoring Sheet (Owner Ron Coalson)
Recommended rating from Chief Handicapper is 21/15/12, an adjustment of -3/-3/-0.

Open floor for comments:

Dennis Conner, Owner "**Menace XXIV**", stated that the boat has not changed in 12 years, with one 9<sup>th</sup> place out of 12 races in the past year. He believes that only the boat should be rated, not the owner or the crew.

Ron Coalson, Owner "**French Bred**", current PHRFSD rating of 24/18/12, compared his rating to SOCAL at 27/24/21.
