a) Rating Reviews:

i) "Lady Max" a Beneteau 47.7 with Sail No. 47142. Owner David Cloyd. Current rating 42/39/36. David is requesting a rating change of +9/+6/+6. The current SOCAL rating is similar to La Sirena with a rating of 42/39/39. His improvements include bottom, keel and rudder faired, rigs have been tuned, new sail inventory and synthetic rigging has been added. A wind chart was presented with a letter of recommended improvements from Wally Henry.

A motion was made for a rating change of +6/+6/+6 - (48/45/42).

- i) "Pendragon II" a Davidson 44 with Sail No. 77177. Owner David Gray. New keel and rudder are reported. In April, the Chief Handicapper had recommended a rating of 12/9/9, with the board adopting a modification to 15/9/9 pending concurrence of the Chief Handicapper, which the Chief Handicapper subsequently considered but declined so the board then reverted the rating to the original 12/9/9 MSP
- ii) "Pandora" a Bavaria 34 with Sail No. 56691. Owner Richard Hosker. Certificate is missing SF. Chief Handicapper recommends a rating of 141/138/138. MSP
- iii) "Red Stripe" a Sonoma 30 with Sail No. 18135. Owner Josh Dean. Josh reports rudder modification to a fixed post. Chief Handicapper recommends a rating of 105/105/105. Luff on the spinnaker is 6" too long. Mark Burrows agreed to verify the spin luff and Walter will confirm dimensions with Chief Handicapper.
- iv) "Viper 640" a V110 with Sail No. 110. Owner Paul Scott. Chief Handicapper recommends a rating of 111/90/-999 (no lifelines) MSP
- v) "Kodachrome" a Beneteau First 36.7 with Sail No. 38747. Owner Jerry Twomey. Chief Handicapper recommends a standard rating of 81/81/84, pending spin dimensions. MSP. Pending owner's verification of spin/OD configuration.
- vi) "Sabbatical" a Catalina 36T with Sail No. 598. Owner Larry Pascoe. Chief Handicapper recommends a rating of 135/135/135. MSP. Roster Secretary to follow up on accurate sail number.
- vii) "Jane" a Shields with Sail No. 52. Owner Barrett Canfield. Chief Handicapper recommends a provisional rating of 183/183/183. Boat will be sailed in OD config. A rating was proposed at 183/183/-999 (no lifelines) **MSP.**
- viii) "Sugar Sue" an Andrews 39 With Sail No. 87308. Owner Larry Schartz Certificate renewal. Chief Handicapper recommends a rating of 63/63/63. MSP – Roster Secretary to follow up on missing information –SF 24.9.
