Walter to follow up with David Servais of SDYC for PHRF participation in yachting Cup/Ed Cotter. Erik Rodgers didn't think it would be a problem for SDYC to continue to host. If SDYC does not want to Host Ed Cotter, Walter will engage with SWYC.

**ii**) I would like to have the Regional Board approve a Corinthian (formerly Racer/Cruiser) Adjustment program at the next Regional Meeting (August 18th). This proposal was originally drafted last year by Cole Price and me, and subsequently reviewed and commented upon by Area C. Robert has reviewed the document and I believe is on board with this approach. I have handed out the proposal once or twice at our Regional Board Meetings, and I believe it is a good time to move forward with this program.

The goal of the Corinthian Adjustment Program is to allow boats that are not optimally configured for racing to apply for Corinthian adjustments. These adjustments are intended to allow boats equipped with cruising equipment like Dacron sails, roller furling mains and jibs, smaller headsails, fixed props, and spinnakers tacked to the bow, to compete by establishing

adjustments from base ratings to take into account these competitive disadvantages. These adjustments will allow sailors to get into, and stay in, PHRF racing without making a major investment in hi-tech sails and other expensive equipment. The Corinthian adjustment program would be implemented under a new Appendix to the PHRF Class Rules (attached) and the Appendix sets out the range of adjustments available, the procedures to get adjustments and other rules regarding the application of the adjustments. Since the Program is meant to apply to boats not fully optimized for racing, the rules make it clear that the program will not apply to boats with PHRF ratings at the faster end of the fleet, and further, since the program is intended to reduce costs, the adjustments available are conservative, to discourage rule beating by competitors modifying their boats to take advantage of the adjustments.
