- 2. From last meeting Beneteau 343, Bien Fait, 343 *Last Meeting Application appears to be incorrect. Need better info.* With additional information the Chief Handicapper recommends 147/147/147. Vote: 12 yes, 0 no, 0 abstentions.
- Sea Weed, Newport 30, 1125, *Chief Handicapper recommends 180/180/180 to be the same as SoCal. Vote: 12 yes, 0 no, 0 abstentions.*

- 1. Need Update Magic Light Hobie 33 Owner claims there is a clerical error on PHRF SoCal Certificate which has not yet been corrected if this is not corrected PHRF SD should change the Area G rating. *Last Meeting No action at this time, tabled for later.* There has still been no action. Walter Shaffer recommends -999/-999/-999 for area G seconded by Joe Saad, 11 yes, 1 no, 0 abstentions. Walter Shaffer offers to make contact with owner. PHRF SoCal to be notified.
- 2. Aquarius Alerion Express 28 Last Meeting Chief Handicapper to investigate this certificate. With additional information Chief Handicapper recommends 150/147/156, Vote: 12 yes, 0 no, 0 abstentions. This boat carries a 155 Genoa not the standard smaller self tacking jib.
- 3. Valkyrie, Bolt 37 sail number 56600 Questions about changes to the fin and keel were submitted but we have specs from Nelson/Marek that shows only weight reduction in bulb (which formed basis of handicap change in November 2015) and no changes to the fin. Chief Handicapper recommends no change as there are not enough race results to review. The assumptions that modifications were made to the fin were unsubstantiated therefore no review now. The rating remains the same. Chief Handicapper to inform PHRF SoCal.
