- Confirm Quorum YES A quorum is constituted by the presence of a quorum of the Executive Board plus representation by a minimum of 3 SDAYC member clubs and a minimum of 3 of the current classes. The Fleet Executive Board can be counted for the purpose of ensuring representation of either the 3 SDAYC member clubs or the 3 classes.
- RATIFY E-VOTES NONE
- TEMPORARY RATINGS ABOUT TO EXPIRE A Temporary Rating may be provided by Chief handicapper in the event a handicap is requested to race in an upcoming race which will take place before a meeting, and the board is unable to vote on the rating (Prior to race). The request should be email approved or voted on at next board meeting to make permanent.

In the event at a board meeting where an owner has submitted an application,

fees are paid, but the Board believes it does not have sufficient data or information to accurately rate a boat, a Temporary rating may be provided with the understanding the owner should submit race results during the three months to show data, to verify the Temporary Rating. Temporary rating may be adjusted after review of results. In the event the data is not provided the temporary rating will be considered expired at the end of 90 days. A new complete application (Minus Fees) will need to be presented to board to have the boat considered again for a PHRF certificate.

- Second Reading: Beneteau 36.7 last meeting: wants same as J105 to change from 81 to 84 RLC 84,84,87 Vote YES 9, NO 0, Abstain 2 This will not take effect until after a review at the next meeting, 2/13/18. Second Reading agreed with Frist Reading Vote YES 9, NO 0, Abstain 2
- Second Reading: Fiasco III last meeting: Owner/member Joe Saad. Rating Review – Chief Handicapper recommends 123,120,123 – Vote YES 6, NO 1, Abstain 3. This will not take effect until after a review at the next meeting. Second Reading agreed with Frist Reading Vote YES - 4, NO - 2, Abstain 4
- CLASS ADJUSTMENTS If a boat is within 6 seconds of a Class Break or if their Performance Factor is within 10% (0.4) of the current cutoff that places boats into Class 2 (sport boats), the owner may request to change to the next lower or higher class. This can be done only once in a calendar year or once for the upcoming or current Yearly Class Championship Series. The Board will agree or not.
