- e. Amendments to the PHRF San Diego Constitution and Bylaws Article III. Organization Change:
 - 1. The organization shall be governed by nine ten Fleet Officers. Eight-Nine are elected officers including: Fleet Chairman, Vice Chairman, Fleet Secretary, Roster Secretary, Chief Handicapper, Fleet Scorer, Data Systems Officer, and PR Officer, and Treasurer. These listed officers shall constitute the Fleet Executive Board and can represent Area G at meetings of PHRF Southern California as required.

• TEMPORARY RATINGS ABOUT TO EXPIRE - A Temporary Rating may be provided by Chief handicapper in the event a handicap is requested to race in an upcoming race which will take place before a meeting, and the board is unable to vote on the rating (Prior to race). The request should be email approved or voted on at next board meeting to make permanent.

In the event at a board meeting where an owner has submitted an application, fees are paid, but the Board believes it does not have sufficient data or information to accurately rate a boat, a Temporary rating may be provided with the understanding the owner should submit race results during the three months to show data, to verify the Temporary Rating. Temporary rating may be adjusted after review of results. In the event the data is not provided the temporary rating will be considered expired at the end of 90 days. A new complete application (Minus Fees) will need to be presented to board to have the boat considered again for a PHRF certificate.

- Needle, Holder 20X with oversize main, Luff 24.08, Foot 9.28 (class max is 9.33), Head Width 1.37 (standard HB/HW = .55) MGU 4.69 MGM 7.02, Upwind sail area is 30 sq. ft. less than standard Holder 20 with 155% Genoa so still underpowered in light air upwind. Request rating remain at 168/162/156 Class 5 vote YES 8, NO 0, Abstain 1

 - o Briar Rose, 56410, Bavaria 42, Class 3, 93/78/75, vote YES 8, No 0, 1 Abstain

OLD BOATS

- Wicked I, Trimaran, 7159 Sail number 7159 belongs to Transformer, Beneteau 52 per SCYA. Not rated by PHRF SoCal. Bob Lang suggests 213/213/213. Must apply for U S sail number. Not rated by PHRF SoCal. From last meeting: Laszlo Svercsics, *owner*, *was present and received info about how to get a number*. Nothing new.
- Lodestar, Beneteau 473, no US Sail number. Not rated by PHRF SoCal. Must apply for U S sail number. 90/81/81 by consent *still needs U S Sail number* Nothing new.
- Oceanis 41 Chief Handicapper has received 3 anonymous requests for review of Oceanis 41, and determined that there maybe an error and after comparisons with PHRF SoCal. Believes the Oceanis 41 should be 108/108/108 not 120/120/120 and suggests advising the owner(s) so that it can be decided at the next meeting. Roster Secretary will notify the owners. Anonymous review of Oceanis 41 to be at January meeting. Roster Secretary to notify all current owners.
- Tenacious Beneteau 44.7 "No pole. Just a shackle behind the stay. It's a G-AP2 asymmetric. By the way, I'm feeling like the rating of 33 is too low for Tenacious. She is a stock, plane-Jane first 44.7. No rod rigging or three spreaders, or oversized pole or 150 headsail, etc. I'm starting to review other first 44.7 ratings to see if 33 is consistent but I feel like this rating is too high." *From Chief Handicapper: this boat is different than Aeolus and recommends* 39/41/41 vote YES 8, NO 0, 1 Abstain

• CLASS ADJUSTMENTS - NONE - If a boat is within 6 seconds of a Class Break it may request to change to the next lower or higher class. This can be done only once in a calendar year or once for the upcoming or

current Yearly Class Championship Series. The Board will agree or not.

ANONYMOUS RATING REVIEW – NONE

FROM PHRF SoCal Class Rules:

- 1. The Regional Board may initiate a Rating Review of a boat owned by a PHRF Member without a request by the Member / owner or by an identified competitor as set forth above in section 4.2 if and only if three (3) PHRF members, within any twelve month period, submit requests that a specific boat be reviewed using the link on the PHRF SoCal website.
- 2. In the event that three such requests are received within one year, the Fleet Secretary shall notify the Chief Handicapper of such requests and thereupon issue notice to the PHRF Member / owner of the boat in question as provided in Rule 4.2a above. The Rating Review shall be conducted pursuant to the provisions of Rule 4.2, except that the names of the three Members who requested the Rating Review shall be confidential and not be revealed except to members of the Executive Board.
- 3. No boat shall be the subject of more than one Anonymous Rating Review within any twelve month period.

SAIL NUMBERS

All boats requesting rating certificates must have a U S Sailing Sail Number. The PHRF SD Board has decided that all boats currently holding a 2017 certificate may continue to use the sail number currently listed on their certificate. However, new boats must comply with the requirement to have a U S Sailing Sail Number. PHRF SD has decided that one design boats do not require a U S Sailing Sail Number as long as they are one of the boats listed in the PHRF SD One Design list (see below). If a certificate is allowed to lapse for one year than when reapplying for a certificate a U S Sailing Sail Number will be required to obtain a certificate. If there is an ownership change then a U S Sailing Sail Number will be required to obtain a certificate. In the event a new boat requests a certificate and it has the same sail number as a boat having a current certificate the boat between these two boats not having a U S Sailing Sail Number must get one to have a certificate.

How to Get a U S Sailing Sail Number:

US SAILING sail numbers are issued in Area 'J' to boats owned by resident members in good standing of yacht clubs affiliated with the Southern California Yachting Association.
