- Proposed Amendment to the ByLaws concerning the possibility that we cannot hold an in person Annual Meeting because of the COVID-19 Virus:

Change to read as follows:

ARTICLE III. ORGANIZATION

4. There shall be an annual meeting scheduled at the conclusion of each season’s Championship Series. The date, time and meeting agenda shall be published. Agenda items include the election of Fleet Officers (*however if because of circumstances beyond the control of the Board of Directors an in person Annual Meeting cannot be held the election will be held through Electronic communication as described in Article IX*) , presentation of Fleet Awards and other regular business of the fleet. Additional meetings may be called at any time by the Fleet Chairman who shall specify the time and place and have the membership notified at least 14 days in advance.

ARTICLE III. ORGANIZATION

Amendments may also be ratified by a USPS Mail Vote response, or through Electronic (E-Mail or Electronic Document Transfer) communication. A majority vote is based on the number of responses received.

1. No vote will be taken amending the Bylaws until 14 days but 7 days by electronic means after members have been notified of the proposed changes.
