 - VPP based PHRF ratings:

This is a motion by the Fleet Secretary to be presented at the next PHRF SD regular Monthly meeting on 6/13/23. It is in the form of a proposed letter to be sent by email to all current members.

Motion to change the Class Rules of PHRF SD so that all PHRF SD ratings will be mathematically calculated based on ratings provided

by each boat owner from either ORR/ORR EZ or ORC/ORC Club beginning in January 2024.

To all current members:

Beginning in 2024 PHRF SD will issue ratings only to boats that provide an ORR/ORR EZ or ORC/ORC Club rating. Each boat owner has the choice to submit either an ORR/ORR EZ or ORC/ORC Club rating.

PHRF SD will use mathematics to calculate a PHRF SD rating from the provided ORR/ORR EZ or ORC/ORC Club rating for each boat in three wind ranges based around the average wind speed of 9.2 kts in San Diego North Bay for the times we race noon to 1700. The average wind speed in San Diego Bay between the hours of noon and 1700 is 9.2 kts from 271 degrees true based on historical data maintained by NAS North Island and San Diego International Airport.

Beginning in 2024 OAs can use the ORR/ORR EZ or ORC/ORC Club ratings or PHRF SD ratings to set classes. Boat owners can petition OAs about whether classes should be based on ORR/ORR EZ or ORC/ORC Club ratings or PHRF SD ratings.

It is anticipated initially that the ORR/ORR EZ or ORC/ORC Club ratings for 2023 will be used for three years to generate PHRF SD ratings for 2024,25,26. All new boats joining PHRF SD must bring a current ORR/ORR EZ or ORC/ORC Club rating from which PHRF SD will calculate a PHRF SD rating that will be good for three calendar years.

It is likely that many boats will petition OAs to go to ORR/ORR EZ or ORC/ORC Club ratings based classes and scoring and some will desire to stay with PHRF SD ratings based classes and scoring.

Dues for 2024 for PHRF SD membership will be \$10 to include a new PHRF SD rating based on the ORR/ORR EZ or ORC/ORC Club rating the boat owner provides.

It is intended that PHRF SD will refund to all current members an amount of money soon to be determined to help defer the cost of obtaining an ORR/ORR EZ or ORC/ORC Club rating.

Action required by each boat owner (current member of PHRF SD) apply <u>now</u> for an ORR/ORR EZ or ORC/ORC Club rating for 2023. If you delay you may not have a rating to begin racing in January 2024.

- TEMPORARY RATINGS ABOUT TO EXPIRE A Temporary Rating may be provided by Chief handicapper in the event a handicap is requested to race in an upcoming race which will take place before a meeting, and the board is unable to vote on the rating (Prior to race). The request should be email approved or voted on at next board meeting to make permanent. In the event at a board meeting where an owner has submitted an application, fees are paid, but the Board believes it does not have sufficient data or information to accurately rate a boat, a Temporary rating may be provided with the understanding the owner should submit race results during the three months to show data, to verify the Temporary Rating. Temporary rating may be adjusted after review of results. In the event the data is not provided the temporary rating will be considered expired at the end of 120 days. A new complete application (Minus Fees) will need to be presented to board to have the boat considered again for a PHRF certificate. The Chief Handicapper may, at his or her discretion, renew the Temporary Rating twice.
